HYPOTHETICAL EXAMPLES


The following hypothetical examples show how the Coupon Payments and Maturity Redemption Amount would be calculated and determined based on certain hypothetical values and assumptions that are set out below. These examples are for illustrative purposes only and should not be construed as an estimate or forecast of the performance of the Reference Unit or the return that an investor might realize on the Notes. The return on the Notes will be calculated based on the price performance of the Reference Unit. Certain dollar amounts are rounded to the nearest whole cent and "\$" refers to the relevant currency for the specific hypothetical dollar amounts and hypothetical prices that the context requires.

Hypothetical values for calculations:

Initial Unit Price*: US\$100.00

Barrier Price: 70.00% of the Initial Unit Price = 70.00% x US\$100.00 = US\$70.00
2023 Autocall Price and First 2024 Autocall Price: 105.00% of the Initial Unit Price = 105.00% x US\$100.00 = US\$105.00
Second 2024 Autocall Price and First 2025 Autocall Price: 100.00% of the Initial Unit Price = 100.00% x US\$100.00 = US\$100.00
Second 2025 Autocall Price and First 2026 Autocall Price: 95.00% of the Initial Unit Price = 95.00% x US\$100.00 = US\$95.00
Second 2026 Autocall Price and First 2027 Autocall Price: 90.00% of the Initial Unit Price = 90.00% x US\$100.00 = US\$90.00
Second 2027 Autocall Price and 2028 Autocall Price: 85.00% of the Initial Unit Price = 85.00% x US\$100.00 = US\$95.00

Example #1 – The Notes are not automatically called as the Closing Unit Price on each Autocall Valuation Date is less than the applicable Autocall Price. The Final Unit Price on the Final Valuation Date is less than the Barrier Price.





Since the Final Unit Price (US\$56.00) on the Final Valuation Date is less than the Barrier Price, the Maturity Redemption Amount is calculated as follows:

Principal Amount + (Principal Amount x Price Return)

US\$100.00 + (US\$100.00 x -44.00%) = US\$56.00 per Note


In this example, since the Closing Unit Price is less than the Barrier Price on all Coupon Valuation Dates, an investor would not receive any Coupon Payments.

An investor would receive a Maturity Redemption Amount of US\$56.00 per Note on the Maturity Date, which is equivalent to an annual compound rate of return of approximately -10.95% per Note.



^{*}The Initial Unit Price of US\$100.00 is a hypothetical Initial Unit Price that has been chosen for illustrative purposes only and does not represent either the actual Initial Unit Price or an estimate or forecast thereof. The actual Initial Unit Price will be equal to the Closing Unit Price on the Initial Valuation Date.

Example #2 – The Notes are not automatically called as the Closing Unit Price on each Autocall Valuation Date is less than the applicable Autocall Price. The Final Unit Price on the Final Valuation Date is greater than or equal to the Barrier Price.



Since the Final Unit Price (US\$76.00) on the Final Valuation Date is greater than the Barrier Price, the Maturity Redemption Amount is calculated as follows:



In this example, an investor would receive a Coupon Payment for each of the 1st to the 30th and the 55th to the 60th Coupon Valuation Dates, but would not receive any Coupon Payments for the 31st to the 54th Coupon Valuation Dates, since the Closing Unit Price on each such Coupon Valuation Date is less than the Barrier Price.

An investor would receive aggregate Coupon Payments of US\$34.65 per Note, and a Maturity Redemption Amount of US\$100.00 per Note, on the Maturity Date, which is equivalent to an annual compound rate of return of approximately 6.13% per Note.

Example #3 – The Notes are automatically called on the 2023 Autocall Valuation Date as the Closing Unit Price on the 2023 Autocall Valuation Date is greater than or equal to the 2023 Autocall Price.



Since the Closing Unit Price (US\$121.00) on the 2023 Autocall Valuation Date is greater than the 2023 Autocall Price, the Maturity Redemption Amount is calculated as follows:



In this example, since the Closing Unit Price is greater than the Barrier Price on each applicable Coupon Valuation Date, an investor would receive Coupon Payments of US\$0.9625 per Note on each of the first six Payment Dates.

An investor would receive aggregate Coupon Payments of US\$5.775 per Note, and a Maturity Redemption Amount of US\$100.00 per Note, which is equivalent to an annual compound rate of return of approximately 11.88% per Note.



Example #4 – The Notes are automatically called on the First 2027 Autocall Valuation Date as the Closing Unit Price on the First 2027 Autocall Valuation Date is greater than or equal to the First 2027 Autocall Price.





Since the Closing Unit Price (US\$95.00) on the First 2027 Autocall Valuation Date is greater than the First 2027 Autocall Price, the Maturity Redemption Amount is calculated as follows:

In this example, an investor would receive a Coupon Payment for each of the 12th to the 48th Coupon Valuation Dates, but would not receive any Coupon Payments for the 1st to th

An investor would receive aggregate Coupon Payments of US\$35.6125 per Note, and a Maturity Redemption Amount of US\$100.00 per Note, on the Maturity Date, which is equivalent to an annual compound rate of return of approximately 7.91% per Note.



HISTORICAL PERFORMANCE

The following graph illustrates the price performance of the Reference Unit during the period beginning on January 2, 2013 and ending on January 13, 2023.
