
If the Index Return on the Final Valuation Date is greater than 0.00%, investors will benefit from the positive Index Return on maturity of the Notes subject to a 600.00% Participation Rate. If the Index Return on the Final Valuation Date is equal to 0.00%, a holder of the Notes will receive only the Principal Amount at maturity.

Potential Downside Risk

If the Index Return on the Final Valuation Date is less than 0.00%, a holder of the Notes will be fully exposed to any negative performance of the Index, meaning that substantially all of such holder's investment may be lost (subject to a minimum principal repayment of US\$1.00 per Note).

Index

Whether there is a return on the Notes and whether the Principal Amount is returned at maturity is based on the performance of the Solactive Core Canadian Large Cap AR Index (the "Index"). The Index aims to track the gross total return performance of the Solactive Core Canadian Large Cap Index TR (the "Target Index"), subject to reduction for a synthetic dividend of 100 index points per annum calculated daily in arrears at the time the Index is calculated (the "Adjusted Return Factor"). The Target Index is a gross total return index that reflects the applicable price changes of its constituent securities and any dividends and distributions paid in respect of such securities. In order for the level of the Index to increase, the level of the Target Index must increase by more than 100 index points per annum from the Initial Valuation Date to the Final Valuation Date.

The Index and Target Index were launched on January 19, 2024. Accordingly, there is very limited performance history for the Index and the Target Index to evaluate the prior performance of the Index and Target Index. The level of the Index may be affected by the volatility of the prices of the equity securities of the issuers comprising the Target Index, meaning that such prices can fluctuate and change considerably in relatively short periods and the performance of such prices cannot be predicted for any future period and as a result an investment linked to Index levels may also be volatile. There is no assurance of the ability of issuers comprising the Target Index to declare and pay dividends or make distributions in respect of the constituent securities of the Target Index or to sustain or increase such dividends and distributions at or above historical levels. The Adjusted Return Factor as a percentage of the Closing Index Level on April 30, 2024 was approximately 5.85%. The foregoing percentage amount is not an estimate or forecast of what any such percentage amount may be over the term of the Notes. The annual dividend yield on the Target Index as of April 30, 2024 was 5.56%, representing an aggregate dividend yield of approximately 31.07% annually compounded over the approximately 5 year term of the Notes on the assumption that the dividends paid on the securities comprising the Target Index remain constant. The foregoing dividend yield information is for comparative purposes only and is not an indication of any future dividends that might be paid or payable on such securities. There is no requirement for the Bank to hold any interest in the Index, the Target Index or the constituent securities of the Target Index.

Initial Valuation Date

June 4, 2024, provided that if such day is not an Exchange Business Day then the Initial Valuation Date will be the first succeeding day that is an Exchange Business Day, subject to the occurrence of any special circumstances (see "Special Circumstances" in the pricing supplement).

Final Valuation Date

May 29, 2029, provided that if such day is not an Exchange Business Day then the Final Valuation Date will be the immediately preceding Exchange Business Day, subject to the occurrence of any special circumstances (see "Special Circumstances" in the pricing supplement).

Record Date

June 1, 2029, provided that if such day is not a Business Day then the Record Date will be the immediately preceding Business Day.

Maturity Redemption Amount

Holders of record on the Record Date will be entitled to an amount payable per Note at maturity (the "Maturity Redemption Amount") as calculated by the Calculation Agent in accordance with the applicable formula below:

If the Index Return on the Final Valuation Date is greater than 0.00%, the Maturity Redemption Amount will equal:

Principal Amount + [Principal Amount × (Index Return × Participation Rate)]

If the Index Return on the Final Valuation Date is equal to or less than 0.00%, the Maturity Redemption Amount will equal:

Principal Amount + (Principal Amount × Index Return)

The Maturity Redemption Amount will be less than the Principal Amount invested by an investor if the Index Return on the Final Valuation Date is less than 0.00%. The Maturity Redemption Amount will be subject to a minimum principal repayment of US\$1.00 per Note. The return on the Notes will not reflect the total return that an investor would receive if such investor owned the securities included in the Target Index.

Index Return

The Index Return is an amount expressed as a percentage (which can be zero, positive or negative) calculated by the Calculation Agent in accordance with the following formula:

(Final Index Level - Initial Index Level) ÷ Initial Index Level



Note Return

The Note Return is an amount expressed as a percentage (which can be zero, positive or negative) calculated by the Calculation Agent in accordance with the following formula:

(Maturity Redemption Amount - Principal Amount) ÷ Principal Amount

Participation Rate

600.00%, applied to any positive Index Return on the Final Valuation Date.

Closing Index Level

The official closing level or value of the Index on a given day as calculated and announced by the Index Sponsor on an Exchange Business Day.

Initial Index Leve

The Closing Index Level on the Initial Valuation Date.

Final Index Level

The Closing Index Level on the Final Valuation Date.

Currency

The Notes are denominated in U.S. dollars. The return on the Notes in U.S. dollars will be based solely upon the Index Return on the Final Valuation Date. Accordingly, the Maturity Redemption Amount payable in respect of the Notes will be unaffected by changes in the exchange rate of the U.S. dollar relative to any other currency. To the extent other assets or income of a holder of the Notes are denominated in another currency, such as the Canadian dollar, an investment in the Notes will entail foreign exchange related risks. See "Risk Factors" in the pricing supplement. Unless otherwise indicated, all dollar amounts appearing in this document are stated in Canadian dollars.

Listing and Secondary Market

The Notes will not be listed on any exchange or marketplace. Scotia Capital Inc. will use reasonable efforts under normal market conditions to provide a daily secondary market for the sale of the Notes but reserves the right to elect not to do so at any time in the future, in its sole and absolute discretion, without prior notice to holders.

Eligibility for Investment

Eligible for RRSPs, RRIFs, RESPs, RDSPs, DPSPs, TFSAs and FHSAs.

Fees and Expenses

There is no selling concession fee payable to the Investment Dealers in respect of the Notes. A fee of up to US\$0.15 per Note sold (or up to 0.15% of the Principal Amount) will be payable directly by the Bank to Desjardins Securities Inc. at closing for acting as the independent agent. The payment of these fees will not reduce the amount on which the Maturity Redemption Amount payable on the Notes is calculated.

HYPOTHETICAL EXAMPLES

The table below is for illustrative purposes only and shows the Maturity Redemption Amount an investor would receive per Note based on various hypothetical Index Returns. There can be no assurance that any specific return will be achieved on the Notes. All examples assume that an investor has purchased the Notes with an aggregate principal amount of US\$100.00 per Note, holds the Notes until the Maturity Date and that no special circumstances have occurred during the term of the Notes (see "Special Circumstances" in the pricing supplement).

⁽¹⁾The Note Return, Maturity Redemption Amount and Annualized Return for the hypothetical Index Return of -100.00% have been adjusted to reflect the minimum principal repayment of US\$1.00 per Note.

The following hypothetical examples show how the Index Return and Maturity Redemption Amount would be calculated and determined based on certain hypothetical values and assumptions that are set out below. These examples are for illustrative purposes only and should not be construed as an estimate or forecast of the performance of the Index or the return that an investor might realize on the Notes. The return on the Notes will be calculated based on the performance of the Index, which reflects the gross total return performance of the Target Index as reduced by the Adjusted Return Factor. Certain dollar amounts are rounded to the nearest whole cent and "\$" refers to the relevant currency for the specific hypothetical dollar amounts and hypothetical prices that the context requires.

Hypothetical values for calculations:

Initial Index Level*: 100.00

Participation Rate: 600.00%, applied to any positive Index Return on the Final Valuation Date

*The Initial Index Level of 100.00 is a hypothetical Initial Index Level that has been chosen for illustrative purposes only and does not represent either the actual Initial Index Level or an estimate or forecast thereof. The actual Initial Index Level will be equal to the Closing Index Level on the Initial Valuation Date.

Example #1 - The Index Return on the Final Valuation Date is equal to or less than 0.00%.

Assume that the Final Index Level on the Final Valuation Date is 49.67

Calculate the Index Return:

(Final Index Level – Initial Index Level) \div Initial Index Level (49.67 – 100.00) \div 100.00 = -50.33%

Calculate the Maturity Redemption Amount:

Since the Index Return is less than 0.00%, the Maturity Redemption Amount will be equal to:

Principal Amount + (Principal Amount × Index Return)
US\$100.00 + (US\$100.00 × −50.33%) = US\$49.67 per Note

In this example, an investor would receive a Maturity Redemption Amount of US\$49.67 per Note on the Maturity Date, which is equivalent to an annual compound rate of return of approximately -13.06% per Note.

Example #2 - The Index Return on the Final Valuation Date is greater than 0.00%.

Assume that the Final Index Level on the Final Valuation Date is 155.32

Calculate the Index Return:

(Final Index Level – Initial Index Level) ÷ Initial Index Level (155.32 – 100.00) ÷ 100.00 = 55.32%

Calculate the Maturity Redemption Amount:

Since the Index Return is greater than 0.00%, the Maturity Redemption Amount will be equal to:

Principal Amount + [Principal Amount × (Index Return × Participation Rate)] US\$100.00 + [US\$100.00 × (55.32% × 600.00%)] = US\$431.92 per Note

In this example, an investor would receive a Maturity Redemption Amount of US\$431.92 per Note on the Maturity Date, which is equivalent to an annual compound rate of return of approximately 33.99% per Note.
