## KEY TERMS

### Issuer

The Bank of Nova Scotia (the “Bank”).

### Index\*

Scotiabank US Top 50 Large Cap Dividend Hedged to CAD Index AR (the “Index”). The Index was launched on March 27, 2025 and is the Bank’s proprietary index.

### Potential Enhanced Upside Performance

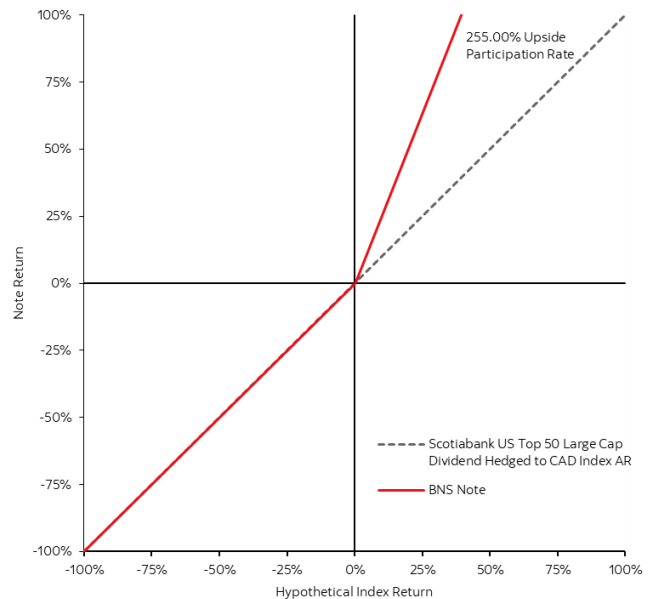
If the Index Return on the Final Valuation Date is greater than 0.00%, investors will benefit from the positive Index Return on maturity of the Notes subject to a 255.00% Participation Rate. If the Index Return on the Final Valuation Date is equal to 0.00%, a holder of the Notes will receive only the Principal Amount at maturity.

### Potential Downside Risk

If the Index Return on the Final Valuation Date is less than 0.00%, a holder of the Notes will be fully exposed to any negative performance of the Index, meaning that substantially all of such holder’s investment may be lost (subject to a minimum principal repayment of \$ 1.00 per Note).

\*The Closing Index Level reflects the gross total return performance of the Target Index as reduced by the Adjusted Return Factor. The Closing Index Level on February 27, 2026 was 1,096.18. The Adjusted Return Factor as a percentage of the Closing Index Level on February 27, 2026 was approximately 4.56%. The foregoing percentage amount is not an estimate or forecast of what any such percentage amount may be over the term of the Notes. The annual dividend yield on the Underlying Index as of February 27, 2026 was 3.54%, representing an aggregate dividend yield of approximately 19.00% annually compounded over the term of the Notes on the assumption that the dividends paid on the securities comprising the Underlying Index remain constant.

### Index

Whether there is a return on the Notes and whether the Principal Amount is returned at maturity is based on the performance of the Bank's proprietary index, Scotiabank US Top 50 Large Cap Dividend Hedged to CAD Index AR (the "Index"). The Index aims to track the gross total return performance of the Scotiabank US Top 50 Large Cap Dividend Hedged to CAD Index TR (the "Target Index"), subject to reduction for a synthetic dividend of 50 index points per annum calculated daily in arrears at the time the Index is calculated (the "Adjusted Return Factor"). The Target Index tracks the performance of the Scotiabank US Top 50 Large Cap Dividend CAD Index TR (the "Underlying Index") and hedges the U.S. currency exposure to Canadian dollars on a one month basis via foreign exchange forward contracts. The Underlying Index is a gross total return index that reflects the applicable price changes of its constituent securities and any dividends and distributions paid in respect of such securities. The performance of the Index will vary above or below the price return version of the Target Index, which version excludes dividends and distributions, depending on whether the amount and timing of reinvested dividends and/or distributions reflected in the Target Index outweighs the impact of the Adjusted Return Factor on the Index. For the calculation of the level of the Underlying Index, any dividends or other distributions paid on the constituent securities of the Underlying Index are reinvested across all the constituent securities of the Underlying Index. The Bank developed, and is the owner, provider and sponsor of the Index, the Target Index and the Underlying Index (the "Index Sponsor"). ### Final Valuation Date

April 18, 2031 (the "Final Valuation Date"), provided that if such day is not an Exchange Business Day then the Final Valuation Date will be the immediately preceding Exchange Business Day, subject to the occurrence of any special circumstances (see "Special Circumstances" in the pricing supplement).

### Record Date

April 23, 2031, provided that if such day is not a Business Day then the Record Date will be the immediately preceding Business Day.

### Maturity Redemption Amount

Holders of record on the Record Date will be entitled to an amount payable per Note at maturity (the "Maturity Redemption Amount") as calculated by the Calculation Agent in accordance with the applicable formula below:

If the Index Return on the Final Valuation Date is greater than 0.00%, the Maturity Redemption Amount will equal:

$$\text{Principal Amount} + [\text{Principal Amount} \times (\text{Index Return} \times \text{Participation Rate})]$$

If the Index Return on the Final Valuation Date is equal to or less than 0.00%, the Maturity Redemption Amount will equal:

$$\text{Principal Amount} + (\text{Principal Amount} \times \text{Index Return})$$

The Maturity Redemption Amount will be less than the Principal Amount invested by an investor if the Index Return on the Final Valuation Date is less than 0.00%. The Maturity Redemption Amount will be subject to a minimum principal repayment of \$1.00 per Note. **The return on the Notes will not reflect the total return that an investor would receive if such investor owned the securities included in the Underlying Index.**

### Index Return

The Index Return is an amount expressed as a percentage (which can be zero, positive or negative) calculated by the Calculation Agent in accordance with the following formula:

**Note Return**

The Note Return is an amount expressed as a percentage (which can be zero, positive or negative) calculated by the Calculation Agent in accordance with the following formula:

$$\frac{(\text{Maturity Redemption Amount} - \text{Principal Amount})}{\text{Principal Amount}}$$

**Participation Rate**

255.00%, applied to any positive Index Return on the Final Valuation Date.

**Closing Index Level**

The official closing level or value of the Index on a given day as calculated and announced by the Index Administrator on an Exchange Business Day.

**Initial Index Level**

The Closing Index Level on the Initial Valuation Date.

**Final Index Level**

The Closing Index Level on the Final Valuation Date.

**Currency**

The Notes are denominated in Canadian dollars and any amounts owing under the Notes will be payable in Canadian dollars.

**Listing and Secondary Market**

The Notes will not be listed on any exchange or marketplace. Scotia Capital Inc. will use reasonable efforts under normal market conditions to provide a daily secondary market for the sale of the Notes but reserves the right to elect not to do so at any time in the future, in its sole and absolute discretion, without prior notice to holders.

**Fees and Expenses**

A selling concession fee of \$2.50 per Note sold (or 2.50% of the Principal Amount) will be payable to the Dealers for further payment to representatives, including representatives employed by the Dealers whose clients purchase the Notes. A fee of up to \$0.15 per Note sold (or up to 0.15% of the Principal Amount) will be payable directly by the Bank to Wellington-Altus Private Wealth Inc. at closing for acting as the independent agent. The payment of these fees will not reduce the amount on which the Maturity Redemption Amount payable on the Notes is calculated.

<sup>(1)</sup>The Note Return, Maturity Redemption Amount and Annualized Return for the hypothetical Index Return of -100.00% have been adjusted to reflect the minimum principal repayment of \$1.00 per Note.

The following hypothetical examples show how the Index Return and Maturity Redemption Amount would be calculated and determined based on certain hypothetical values and assumptions that are set out below. **These examples are for illustrative purposes only and should not be construed as an estimate or forecast of the performance of the Index or the return that an investor might realize on the Notes.** The return on the Notes will be calculated based on the performance of the Index, which reflects the gross total return performance of the Target Index as reduced by the Adjusted Return Factor. Certain dollar amounts are rounded to the nearest whole cent and “\$” refers to the relevant currency for the specific hypothetical dollar amounts and hypothetical prices that the context requires.

**Hypothetical values for calculations:**

Initial Index Level\*: 100.00

Participation Rate: 255.00%, applied to any positive Index Return on the Final Valuation Date

*\*The Initial Index Level of 100.00 is a hypothetical Initial Index Level that has been chosen for illustrative purposes only and does not represent either the actual Initial Index Level or an estimate or forecast thereof. The actual Initial Index Level is equal to the Closing Index Level on the Initial Valuation Date.*

**Example #1 – The Index Return on the Final Valuation Date is equal to or less than 0.00%.**

Assume that the Final Index Level on the Final Valuation Date is 49.67

*Calculate the Index Return:*

$$\text{(Final Index Level – Initial Index Level)} \div \text{Initial Index Level}$$
$$\text{(49.67 – 100.00)} \div 100.00 = -50.33\%$$

*Calculate the Maturity Redemption Amount:*

Since the Index Return is less than 0.00%, the Maturity Redemption Amount will be equal to:

$$\text{Principal Amount} + (\text{Principal Amount} \times \text{Index Return})$$
$$\text{\$100.00} + (\text{\$100.00} \times -50.33\%) = \text{\$49.67 per Note}$$

In this example, an investor would receive a Maturity Redemption Amount of \$49.67 per Note on the Maturity Date, which is equivalent to an annual compound rate of return of approximately –13.06% per Note.

**Example #2 – The Index Return on the Final Valuation Date is greater than 0.00%.**

Assume that the Final Index Level on the Final Valuation Date is 155.32

*Calculate the Index Return:*

$$\text{(Final Index Level – Initial Index Level)} \div \text{Initial Index Level}$$
$$\text{(155.32 – 100.00)} \div 100.00 = 55.32\%$$

*Calculate the Maturity Redemption Amount:*

Since the Index Return is greater than 0.00%, the Maturity Redemption Amount will be equal to:

$$\text{Principal Amount} + [\text{Principal Amount} \times (\text{Index Return} \times \text{Participation Rate})]$$
$$\text{\$100.00} + [\text{\$100.00} \times (55.32\% \times 255.00\%)] = \text{\$241.07 per Note}$$

In this example, an investor would receive a Maturity Redemption Amount of \$241.07 per Note on the Maturity Date, which is equivalent to an annual compound rate of return of approximately 19.24% per Note.
