Re: Notice of Potential Adjustment Event – The Bank of Nova Scotia Principal at Risk Notes set out in Appendix A attached hereto (each a “Note”, and collectively the “Notes”)

This notice is to advise holders of the applicable Notes that a “Potential Adjustment Event”, as defined in the respective Prospectus (defined below) for the Notes, has occurred in respect of TC Energy Corporation (TSX ticker: TRP) (“TRP”), the common shares of which are included in the notional portfolio (the “Reference Portfolio”) of each of the respective Notes. On October 1, 2024, TRP announced that it has completed the spin-off of its liquids pipelines business, by way of plan of arrangement, into South Bow Corporation (TSX ticker: SOBO) (“SOBO”).

In accordance with the terms and conditions of the Notes, Scotia Capital Inc., in its capacity as Calculation Agent for the Notes, has determined that as a result of the Potential Adjustment Event, the common shares of SOBO will be added to the Reference Portfolio of each of the respective Notes. Effective as of October 2, 2024, the Calculation Agent has adjusted the weighting and the Initial Share Price of TRP using an adjustment factor of 0.911, and has determined the weighting and the Initial Share Price of the common shares of SOBO, for all purposes associated with each of the Notes, which are posted for each applicable Note on the Bank’s structured notes website at www.scotianotes.com.

The terms and conditions of the Notes specified in the applicable Pricing Supplement, together with the applicable short form base shelf prospectus and applicable prospectus supplement (collectively, the “Prospectus”) shall be read to apply to both TRP and SOBO.

Capitalized terms used but not defined herein have the meanings ascribed to them in the Prospectus.
